\$2620 plus tax for Golf Pass if Paid Annually (ask about quarterly pricing)

## *Family Annual Golf Pass*

---

- Unlimited golf for married couple including dependent children from either spouse through age 21 at The Golf Club at StoneBridge and Olde Oaks Golf Club
- Unlimited access to the driving range
- Annual Cart Plan available (Operator must have a valid driver's license)
- Trail Fee Plan available (Operator must have a valid driver's license and cart registered with the Club)
- 14 day advance tee times
- Discounts on Pro Shop Merchandise

\$3320 plus tax for Golf Pass if Paid Annually (ask about quarterly pricing)

\$1430 plus tax for Cart/Trail Fee Plan if Paid Annually

## *Junior Annual Golf Pass*

---

- Unlimited golf for individual 17 Years old or younger at The Golf Club at Stonebridge and Olde Oaks Golf Club
- Unlimited access to the driving range
- Annual Cart Plan available (Operator must have a valid driver's license)
- 14 day advance tee times
- Discounts on Pro Shop Merchandise

\$1500 plus tax for Golf Pass if Paid Annually (ask about quarterly pricing)

Prices do not include tax. Annual Golf Passes must be paid in advance annually or quarterly.

Contracts begin at the 1<sup>st</sup> of each quarter and all contracts are for 12 months.

### *Golf Team Pass*

---

- Unlimited golf for individual 17 Years old or younger at The Golf Club at Stonebridge and Olde Oaks Golf Club
- Unlimited access to the driving range
- Annual Cart Plan available (Operator must have a valid driver's license)
- 14 day advance tee times
- Discounts on Pro Shop Merchandise

\$500 plus tax. Pass is for the months of January-April only and must be paid in advance.

### *Non Resident*

---

- Unlimited golf for individual 18 years or older at The Golf Club at StoneBridge & Olde Oaks Golf Club
- Available to individuals whose permanent residence is outside a 50 mile radius from The Golf Club at Stonebridge. Documentation required.
- Unlimited access to the driving range
- Annual Cart Plan available (Operator must have a valid driver's license)
- Trail Fee Plan available (Operator must have a valid driver's license and cart registered with the Club)
- 14 day advance tee times
- Discounts on Pro Shop Merchandise

\$2380 plus tax for Golf Pass if Paid Annually (ask about quarterly pricing)

\$990 plus tax for Cart/Trail Fee Plan if Paid Annually

Prices do not include tax. Annual Golf Passes must be paid in advance annually or quarterly.

Contracts begin at the 1<sup>st</sup> of each quarter and all contracts are for 12 months.

#### **Golf Cart Rental Agreement – Assumption of Risk Agreement Voluntary Release**

I hereby waive, release covenant not to sue and to hold harmless the owners and operators of the golf course or any of their officers, employees, or agents from any and all claims of damage in connection with my rental and use of the golf cart(s), except to the extent such damage was caused by the intentional acts or gross negligence of such entities or persons. This agreement shall apply to myself as well as those who, under my permission, may use or ride in said golf cart(s). These risks include, but are not limited to: collisions involving other carts, injury to persons or property while participating in the game of golf and injuries by an errant golf ball. I agree to assume all of the above mentioned risks. Further, I agree to return said golf cart(s), following its intended use in as good condition as I received. I agree to pay for any damages that are sustained to the golf cart(s), while in my possession. I have read this agreement and fully understand its contents. By signing this Agreement, I understand that I am releasing the owners and operators of the golf course and their officers, employees, agents and all other representatives of any and all liability.

#### **Rules of Operating a Golf Cart**

1. Only two persons and two sets of golf clubs are allowed per golf cart
2. Please utilize cart paths around all tees and greens
3. All traffic controls must be adhered to at all times
4. Wet areas and tall grass areas must be avoided at all times
5. A valid driver's license is required to operate a golf cart
6. Management reserves the right to refuse the use of any golf cart for any reason
7. Players must share Club owned golf carts at all times

I am familiar with the operation and use of said golf cart(s). I agree to operate said golf cart(s) in accordance with the rules of operation listed above.

Passholder agrees to abide by all updated Club rules and regulations as they may be modified during contractual agreement.

The Golf Club at Stonebridge reserves the right to terminate this program any time by giving notice in writing to all Annual Golf Passholders 60 days prior to termination. Upon termination of the program, the Annual fee(s) collected will be refunded to the passholder(s) on a pro rata basis for the remaining months in each annual golf program. I fully understand the parameters of the program(s) offered and agree to all its terms and conditions. The Club will have the right to host tournaments and other events at the Club without compensation to its passholders on the dates and times selected by the Club. The Club will be marketed in print advertisements and other media. All payments and deposits made toward an Annual Golf Pass are non-refundable unless following death in which case a refund is provided to a spouse/estate on a pro rata basis. An Annual Pass is non-transferrable.

If the Club prevails in a lawsuit to collect on this note, the Passholder will pay the Club's court costs, collection agency costs, and attorney's fees in an amount the court finds to be reasonable. ***Annual Passes purchased with a credit card will be subject to a 3% service charge.***
